# Funding Changes in the Disability Sector

The last few months have been monumental for many peak disability advocacy organisations. Changes to the Department of Social Services grant system has left many organisations high and dry without the security of future funding.

These organisations include Blind Citizens Australia, Deaf Australia and the Deaf Forum of Australia, Physical Disability Australia, Down Syndrome Australia and Brain Injury Australia. These peak bodies play a vital role in supporting people living with disability and acting as their voice. They are the experts on their subject matter and play a critical role in charting the diversity of disability experience. The government's decision to cease funding to these groups is catastrophic because it undermines the diverse voices within the disability community at a time when those voices need to be heard the most during the NDIS rollout.

At the end of January the situation developed with the Minister for Social Services, the Hon. Scott Morrison, announcing the Government would provide new bridging funding to "ensure continuity of front line community services" affected by the grant tendering process.

Minister Morrison said the bridging funding would ensure service gaps don't emerge in critical online services. "Providers of ongoing frontline services under the grants programme will have their funding extended to 30 June 2015 while new services are properly established and clients are appropriately referred," he said.

We have been very vocal on this topic, issuing email alerts to our stakeholders highlighting our thoughts and recommendations, and commenting in the media about our concerns – particularly in *The Age, The Sydney Morning Herald* and *Pro Bono Australia*. ## **National Inquiry into Abuse**

The Senate has announced it will launch a national inquiry into the abuse of people living with disability in institutional and residential settings in Australia.



The announcement is a welcome relief for many disability advocates who have been campaigning for a national inquiry following the joint Fairfax Media/ABC Four Corners investigation which uncovered multiple instances of alleged abuse at Yooralla.

The Assistant Minister for Social Services, Mitch Fifield, said a national inquiry was not appropriate because disability services were a state-based issue. However, Greens Senator Rachel Siewart, who initiated the inquiry, said it was ridiculous to consider abuse a solely state issue.

"It is happening all over the country and needed a national approach. This is an important step towards shining a light on an issue that has gone unacknowledged for too long," Senator Siewart said.
